Bids will be received by the Champaign County Commissioners at their office located at 1512 South US 68, Suite A-100, Urbana, Ohio 43078 on February 20, 2018 at 9:00 a.m. for the furnishing and installation of reinforced concrete box beams and related materials on Neff Road in Mad River Township, Champaign County, Ohio. Bids shall be accompanied by a bid guaranty bond in the amount of 100% of the bid or a certified check, cashier's check or letter of credit in the amount of 10% of the bid in accordance with ORC 153.54. Bids shall be submitted in sealed envelopes marked "Neff Road 88-0040 Bridge Beams Bid". Specifications are on file at the office of the Champaign County Engineer, 428 Beech Street, Urbana, Ohio 43078 and online at <http://engineer.co.champaign.oh.us> .

Specifications for Furnishing and Installing Prestressed Concrete Beams
for a Champaign County Bridge
BR88-0040 on Neff Road

1. Bids will be received by the Champaign County Commissioners in their office at 1512 South U.S. 68, Suite A-100, Urbana Ohio 43078, February 20, 2018 at 9:00 a.m. The bids must be delivered in a sealed envelope with "Neff Road 88-0040 Bridge Beams Bid" clearly visible on the envelope.
2. Bids shall be accompanied by a bid guaranty bond in the amount of 100% of the bid or a certified check, cashier's check or letter of credit in the amount of 10% of the bid in accordance with ORC 153.54. The successful bidder shall be required to provide a performance bond in the amount of 100% of the bid. If the bid is accompanied by a bid bond, the name and address of the agent and surety company must be provided.
3. Bidders shall include a lump sum amount bid for materials shown on the plan and for the use of service items including erection slings. Materials shall include 7 each, B27-48 prestressed concrete bridge beams, 54'- 0" in length center of bearing to center of bearing, with 16 degree left forward skew designed for Ohio HL-93 loading and with load rating (including special hauling vehicles) provided; 14 each 1"x5"x48" elastomeric bearing pads (D=50) with a 3" hole centered; each fascia beam shall include 8 Type 2 guardrail posts centered with standard 6'-3" spacing and 68'-9" of tubular back up; fascia beams shall be sealed 12" in width on the top of the beam, along the fascia, and 12" in width under the deck with an epoxy-urethane sealer; and tie bars.
4. Bidders shall submit a lump sum bid for furnishing of all materials in item 3 and the installation of the prestressed beams on concrete cap on pile abutments prepared by county forces. W-Beam guardrail and grouting will be installed by the county.
5. Bids are F.O.B. job site on Neff Road, 200 feet south of 2090 Neff Road, Urbana, Ohio 43078, Champaign County, Ohio. Beams shall be ready for delivery and setting in July 2018.

Upon notification that materials are ready for delivery and certification that all materials conform to the specifications the successful bidder may invoice the County Engineer for 70% of the bid price. The balance shall be invoiced after delivery of the materials. An award will not be made to any bidder, including the lowest and best bidder or the lowest responsive and responsible bidder against whom a finding for recovery has been issued by the Ohio Auditor of State, if the finding for recovery is unresolved, as provided in Section 9.24 of the Ohio Revised Code, whether or not it is clear that any funds used in this project could be deemed to be "state funds". A bidder with an unresolved finding for recovery shall be deemed not a best bid or not a responsible bid.

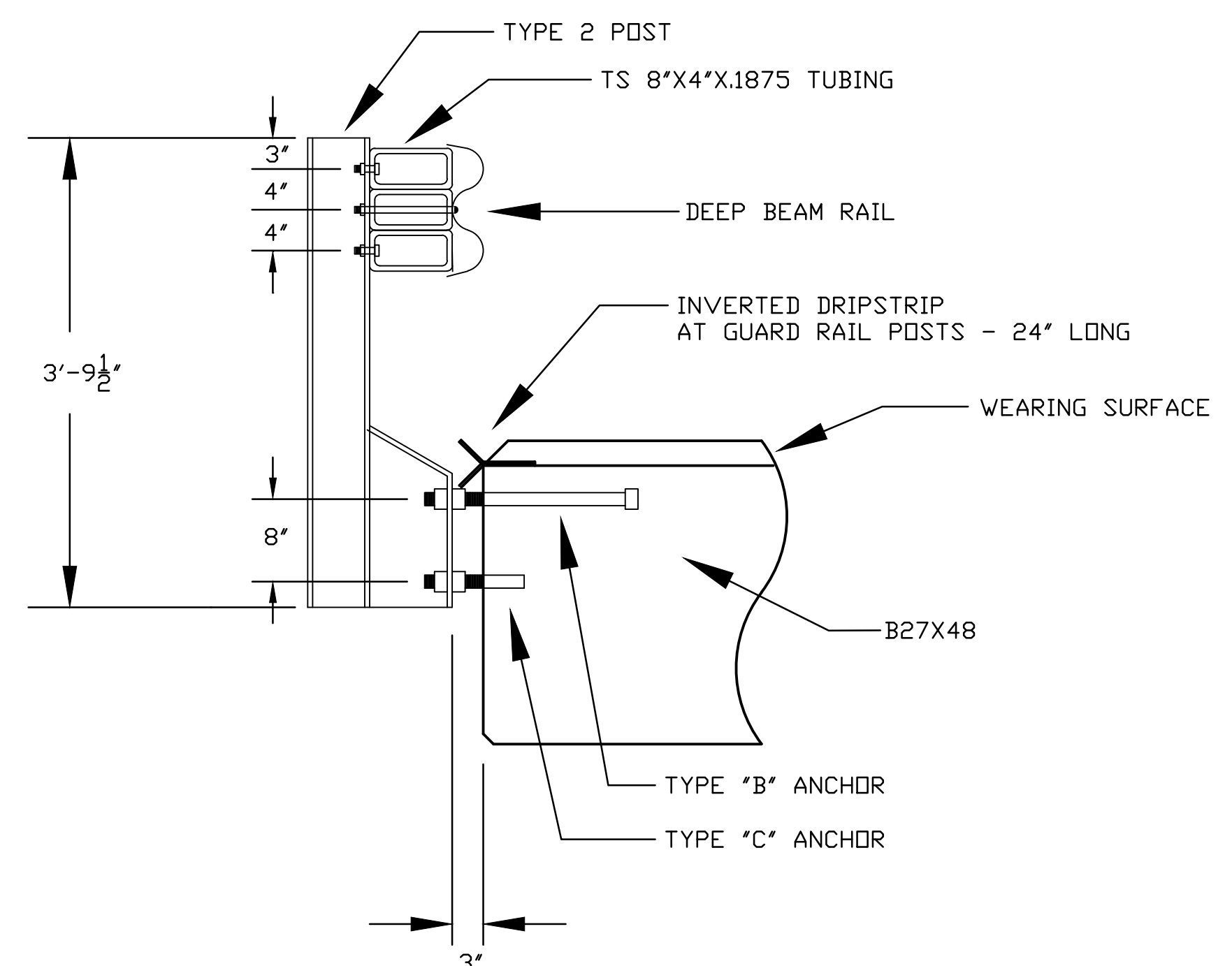
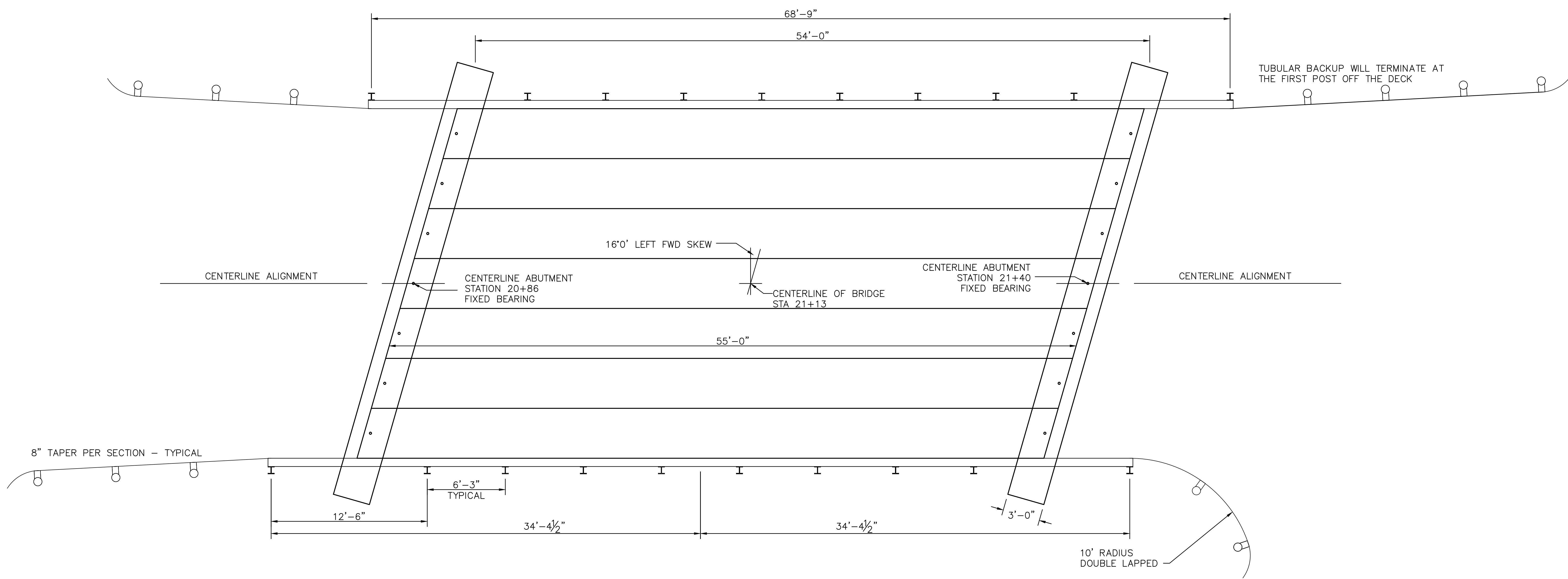
