Bids shall be accompanied by a bid guaranty bond in the amount of 100% of the bid or a certified check, cashier's check or letter of credit in the amount of 10% of the bid in accordance with ORC 153.54. Bids shall be submitted in sealed envelopes marked "Pisgah Road 236-0072 Steel Bridge Bid". Specifications for Furnishing and Installing a Steel Beam Superstructure  
For Champaign County Bridge BR236-0072 on Pisgah Road.

1. Bids will be received by the Champaign County Commissioners in their office at 1512 South U.S. 68, Suite A-100, Urbana Ohio 43078, July 24, 2018 at 9:15 a.m. The bids must be delivered in a sealed envelope with "Pisgah Road 236-0072 Bridge Steel Beam Bridge Bid" clearly visible on the envelope.
2. Bids shall be accompanied by a bid guaranty bond in the amount of 100% of the bid or a certified check, cashier's check or letter of credit in the amount of 10% of the bid in accordance with ORC 153.54. The successful bidder shall be required to provide a performance bond in the amount of 100% of the bid. If the bid is accompanied by a bid bond, the name and address of the agent and surety company must be provided.
3. Bidders shall include a lump sum amount bid for furnishing the materials shown on the plan.
4. Bidders shall submit a lump sum bid for furnishing of all materials in Item 3 and the installation of the steel beam superstructure on existing concrete abutments prepared by county forces.
5. Bids are F.O.B. job site on Pisgah Road, approximately 450 feet east of 3260 Pisgah Road, Urbana, Ohio 43078, Champaign County, Ohio. The superstructure shall be delivered and assembled by October 19, 2018.

Upon notification that materials are ready for delivery and certification that all materials conform to the specifications the successful bidder may invoice the County Engineer for 70% of the bid price. The balance shall be invoiced after delivery of the materials. An award will not be made to any bidder, including the lowest and best bidder or the lowest responsive and responsible bidder against whom a finding for recovery has been issued by the Ohio Auditor of State, if the finding for recovery is unresolved, as provided in Section 9.24 of the Ohio Revised Code, whether or not it is clear that any funds used in this project could be deemed to be "state funds". A bidder with an unresolved finding for recovery shall be deemed not a best bid or not a responsible bid.
